Monday December 15, 2014 – 7:00 P.M

Mayor Huse announced the time and date duly noted and called the meeting to order.

Councilman Charles Evans gave the invocation.

Mayor Huse called roll for the councilmen present. Those present included: Russell Davis, Jeremy Nelson, Charles Evans, and Henry Winsor.

Councilman Charles Evans made a motion to approve the minutes for Regular Session on November 17, 2014. Henry Winsor seconds the motion. Motion approved.
